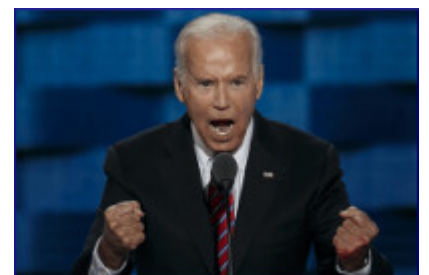


Last October, in his efforts to win the presidential elections, he said:

to ensure he is the next president of the United States,” HRC-president Alphonso David said.

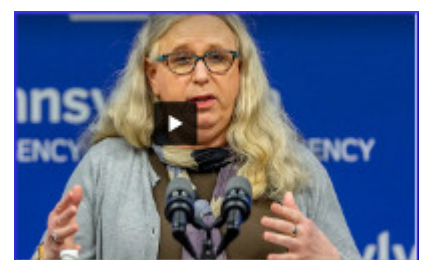

The American College of Pediatricians have published a scientific paper: ‘Sex is a Biological Trait of Medical Significance’,

“In the midst of society’s questioning of the gender binary, the American College of Pediatricians (ACPed) is concerned that the field of medicine risks denying the reality of biological sex.

Sex is a dimorphic, innate trait defined in relation to an organism’s biological role in reproduction. In humans, primary sex determination occurs at fertilization and is directed by a complement of sex determining genes on the X and Y chromosomes. This genetic signature is present in every nucleated somatic cell and is not altered by drugs or surgical interventions.

Sex differences arise from at least four different genetic mechanisms, in addition to the actions of sex hormones and environmental influences. Consideration of these innate differences is critical to the practice of good medicine and to the development of sound public policy for children and adults alike.”

They state how we are witnessing how politically correct doctors have now even come to declare that it would be *“unscientific”* to use chromosomes, hormones, reproductive organs, genitalia and secondary sex characteristics to override gender identity.

Who says you are male?

They write that no one can know whether individuals are male or female unless the individual in question makes it known. Accordingly, pediatricians are ever more being cautioned against *“assigning a sex”* to newborns for fear that this could conflict with the infants’ self-declared gender identity later in childhood.

The truth is, however, that the physical and biological facts are not a state of mind that one can *“identify”* into (or out of) at will. Pediatricians do not *“assign”* an infant’s sex; they merely announce it, based upon the physical reality of the infant’s body before them.

On April 12, 1633, Galileo was ordered to turn himself in to the Holy Office in Rome to begin trial for holding the belief that the Earth revolves around the sun, which was deemed heretical by the Catholic Church at the time. Standard practice demanded that the accused be imprisoned and secluded during the trial.



As of 2021, so-called '*conversion therapists*' find themselves imprisoned for up to ten years in Victoria, Australia, for their denying the new realities of the radical-gay mob and for their maintaining that the "*transgender revolution*" is a software issue only.

The growing radical gay-affiliated movement to deny the physical reality of sexual dimorphism leads to a dangerous dismissal of science and medical ethics. This social coercion will cause severe harm to individuals and society at large if embraced.

The mental condition of Gender Identity Conflict rests largely upon a psychological discomfort with one's biological sex, and is neither innate nor immutable. It does not in any way determine biological sex.

The inappropriate sense of gender has been proven to disappear in up to 98% of the cases as long as it is not affirmed or "*celebrated*". It is quite worrying that activists and politically correct doctors alike, always fail to mention these statistics. They succeed in telling "*the truth*", but not "*the whole truth*", let stand "*nothing but the truth*".

Change? What change?

Administering sex hormones and other drugs can alter appearance and bodily functioning to varying degrees, but these chemicals do not change biological sex. No amount of medical intervention can "*transition*" any person from one sex to the other. The term itself is fake news. You are not going anywhere, certainly not in ten years time after the initial drug party and the honeymoon after surgery fade away, as the side effects ultimately take their lethal toll.

At age 35, prepare to die, because that is the average age of death due to incessant suicide attempts and the ultimate side-effects of the drugs being administered, namely bloodclots, cancer, drug-induced depression and suicidality, osteoporosis, fractures, and the drug-induced diabetes syndrome.

We see activist colleagues going along with the delusion and adding to the agonizing conflict in the individual's mind. After all, doubt is always on the lure. How else can up to 98% get over it if healthy doubt was not present? And that doubt comes from the working of the genes, not from the external world.

How about Intersex?

Intersex conditions (the I in the term LGBTI) are disorders in which normal sexual differentiation and function are disrupted. Some argue that the intersex condition demonstrates the existence of more than two sexes. However, this condition does not represent additional reproductive organs, gonads or gametes. Therefore, by definition, the intersex condition does not constitute additional sexes.

Human sex is a binary, not a spectrum. In reality, the intersex condition is a rare developmental disorder affecting 0.02% of the population in which either genitalia are ambiguous in appearance, or an individual's sexual appearance fails to match what would be expected given the person's sex chromosomes. Reflecting the disordered nature of this condition, all forms of the intersex condition are associated with impaired fertility.

Conclusion

Sex is defined according to the specific reproductive role of a member of a huge class of species in nature, where a member is structurally organized to produce the egg or to contribute the sperm.

Among humans, sex is a dimorphic, innate and immutable trait established at fertilization by sex determining genes located on the X and Y chromosomes. This sexual dimorphism is genetically programmed and is present in every cell of the body; sex does not and cannot change. The presence of X and Y chromosomes correlates with a person's definitive sex phenotype in 99.98% of all people. The 0.02% of people with disorders of sex development (DSD), more commonly referred to as intersex conditions, represent males and females with inborn disorders affecting the external genitalia and/or reproductive organs among other systems.

Public policy

Genetics is the reason why a male who self-identifies as female remains male, and explains why giving hormones like estrogen to a male does not transform him into a female. Drugs do not alter his genetics; he remains male in every cell of his body. For females, it is the other way around. There is no scientific justification for allowing, let alone mandating, males access to female-specific social spaces such as restrooms, homeless shelters, prisons and the like.

The individual has merely a mental conflict between two antagonistic identities within the same person, and the confused state of mind has been demonstrated to heal in 98% of the cases, as is mentioned in the psychiatric DSM-5 manual itself, as long as the normal hardware-based genetic identity is affirmed and respected, and not the flimsy software-induced array of doubts and preoccupations about gender.

Based on sound science, all males with GID should be barred from competing against females because their body is still very male in so many ways despite huge quantities of female hormones. Plastic surgery and the injections of inappropriate levels of hormones do not create a level playing field in sports.
